DIRECTIONS FOR USE

Agitate contents well before use.

Use appropriate personal protective equipment and handling equipment. Use within 48 hours of dilution.

For use on ponds or dams. Spray out grass cover before initial charge. Dilute 1:20 – 1:40 with water before carrying out initial charge. Inject into water body rather than spray onto crust. Once crust removed dilute 1:20 and spray the entire surface of the pond with a high pressure spray.

For Pad Washdown. Pour undiluted onto pad and wash down areas.

TYPICAL APPLICATION RATES

DAILY APPLICATION RATE FOR PAD OR WASHDOWN

Upto 50 Cows - 0.5 litres	51 to 150 Cows - 1.0 litres
151 to 250 Cows - 1.5 litres	251 to 450 Cows - 2.0 litres
451 to 650 Cows - 2.5 litres	651 to 850 Cows - 3.0 litres

EFFLUENT PONDS AND DAMS

Rates may vary depending on the thickness of submerged solid material and floating islands.

Pond Area	Applications (Litres of Digest It)
50 x 25 meters or less	20 Litres
75 x 25 meters	40 Litres: 20 Litres initial treatment, 20 Litres from 14 to 21 days
100 x 40 meters	60 Litres: 20 Litres initial treatment, 20 Litres from 14 to 21 days, 20 Litres 21 days later.

NOTE: The rates suggested above should be used as a guide only. Each farmer's climatic conditions, water quality and farming practices may differ and thus require alterations to these rates to achieve optimal results.
