

STORAGE AND HANDLING

Do not store mixed product. DO NOT return product to the container. Store out of direct sunlight and below 30°C, away from children, animals, food and feed.

Shelf life of 18 months when stored per directions.

DIRECTIONS FOR USE

Use appropriate personal protective and handling equipment. When applying by boom spray use 80 to 100 micron screen on the main filter. Blockages can occur if neat product reaches the filter system.

AGITATE BEFORE USE

Add HydraFish separately and last when using other products. Add slowly to a to a near full spray tank while actively agitating.

Following use allow adequate time to flush the irrigation system with clean water, including all mainlines, submains and lateral delivery lines.

COMPATIBILITY

Before tank mixing, jar test all added products for compatibility of use.

TYPICAL APPLICATION

For trees, vines and vegetables 10 to 15 L/ha every 14 to 21 days; initially as a ground application and then as foliar applications.

Foliar spraying is not recommended 2-3 weeks prior to harvest.

For pasture and turf 20 L/ha at 21 day intervals.
