

## STORAGE AND HANDLING

Do not store mixed product. Store out of direct sunlight and below 30°C, away from children, animals, food and feed. Shelf life of 36 months when stored per directions.

## AGITATE BEFORE USE

Half fill spray tank with water. Add recommended amount of HydraSea 50. Continue to add water under agitation to bring volume up to full. Continue agitating until completely mixed. Be aware of risk of blow under windy conditions. Following use allow adequate time to flush the irrigation system with clean water, including all mainlines, submains and lateral delivery lines.

## COMPATIBILITY

Before tank mixing, jar test all added products for compatibility of use. Not recommended to mix with calcium products, strong acidic, or strong oxidising products.

## TYPICAL APPLICATION

Boom Spray, Fertigation or Aerial.  
Typical application rate 0.25 to 0.50 L/ha of HydraSea 50.  
Apply with enough water to thoroughly cover foliage.  
Minimum dilution 1L HydraSea 50 in 50L of water.
